Coronavirus Support. Depending on Government guidance on containing and eradicating the COVID-19 virus, the Village Coronavirus Support Group will continue its operations as long as required. These local volunteers have been assisting vulnerable and elderly residents who are self-isolating due to COVID-19. This help includes picking up supplies, posting mail, collecting prescriptions, gardening and assistance with pets. The volunteers are also there for a friendly phone call. **Playing Field Playground.** The Government has now allowed playgrounds to open, with certain hygiene and social distancing needs requested of parents, guardians and carers. These include:

- bringing hygiene products to clean any clear touch points on any equipment used, such as the seesaw handles, slide handrails and benches,
- bringing hand sanitiser gel or wipes to clean child(ren)'s hands
- closely supervise child(ren) whilst using the play equipment
- ensure you and child(ren) do not to touch faces, and cough or sneeze into a tissue, or arm when a tissue is not available
- ensure child(ren) do not to put their mouths on equipment or their hands in their mouths
- adhere to the 2m social distancing with other users wherever possible, but never less than 1m
- undertake hand hygiene including washing/sanitising hands more often than usual, for 20 seconds using soap and water or approved gel and foam sanitiser, particularly at the beginning and end of play

Please respect these points when using the play equipment. The sports court can be used for tennis, to be restricted to two people or a family group, observing social distancing rules. Guidance is affixed to the entrance to the court. Contact me for coded access number. The playing field itself is available for individual or family leisure, again respecting social distancing rules but not for gatherings of any sort.

Play Equipment Project. Following a decision at July's Parish Council meeting this project will be taken forward, with a planned completion date of 31<sup>st</sup> October 2020. This sees the current fixed play equipment i.e. swings, slide, climbing frame, seesaw and toddlers play area being refurbished through self-help. As promulgated in July's Newsletter an all-weather surface is to be installed under this equipment to allow year-round use. Additionally, we will purchase and fit a basket swing, to allow a range of children the chance to use the play area; finally, we will procure and fit three exercise stands on the field, to be used to promote a healthy lifestyle. My great thanks go to Councillor Alan and Mrs Alison Vaughan for their hard work in refurbishing the fixed play equipment.

There have been instances locally of unscrupulous trades people pressurising vulnerable residents through cold calling on the doorstep to undertake nugatory work on property etc and charging exorbitant prices. Villagers should always carefully consider any cold call proposals, especially on the doorstep and take advice from friends and neighbours; it is recommended that any cold caller's proposals are rejected, and no hasty decision is made. The Police can be contacted on 101 to report such incidents.
