**Rippingale Feast 2020**. It is with a heavy heart that the Rippingale Feast for 2020 has been cancelled due to Covid -19. We hope to reconvene for the Feast in 2021, but in the meantime the Feast Committee wish you all a very safe summer.

**Nature Notes During Lockdown.** Communing with nature brings a great source of comfort and can significantly contribute to maintaining your mental wellbeing during these difficult times. If you are lucky enough to be allowed to leave your home, then Rippingale affords some fabulous walks on which our beautiful countryside and abundant wildlife can be enjoyed, more of which later.

If you are completely locked down, then you will be amazed by how much wildlife you can find in your garden. We have a relatively large garden managed (or mismanaged some would argue!) to enhance its wildlife value. It has been wonderful seeing spring unfold in the garden with native plants such as Lesser Celandine and Early Dog Violet flowering throughout March and many other species appearing in April. We have planted some native wildflowers too and Primroses, Cowslips and Snakes- head Fritillary complement the cultivated plants in our borders.

Like many birders I am now keeping a lockdown bird list of those seen in and over the garden. This has now passed forty species including the first Chiffchaff on the 20<sup>th</sup> of March and regular sightings of Buzzards, Red Kites and even Ravens overhead.

The sunny weather has brought out the butterflies which include the stunning yellow Brimstones as well as up to four tiny Holly Blues at any one time. Bees are also in evidence with Buff-tailed Bumblebees and Red Mason Bees observed.

Our ponds are also hosting wildlife and one designated for wildlife only was boiling with spawning frogs in March. They are now tadpoles and have been joined by Smooth Newts and other aquatic species. Whilst weeding the pond, I came across the nymph of a Southern Hawker Dragonfly fully two inches long! I also found some Toad spawn in our fishpond.

If you can get out for your daily exercise, then walks are available in all directions from Rippingale. Now that Messers Dorrington have kindly, temporarily opened the old railway track between Rippingale Station and Dunsby Gatehouse there is a lovely circular walk available to all, taking in the top end of our fens as well as rolling pastures off Doctors Lane.

Dear Parishioners of the Ringstone in Aveland Group,

For your information I have attached document links, one from the Church of England and the other from our Bishops, both of which relate to the use of our church buildings and the current situation.

On Thursday, 14<sup>th</sup> May I invited all members of our 5 PCCs to a Zoom meeting to lay out and discuss my position in relation those these documents and the latest government statement.

28 PCC members attended, and I am delighted to say that without exception, all expressed the same view as me, that we should for the time being continue with services recorded and streamed from the vicarage.

There are several reasons for this decision. Among them (but not limited to):

- 1. Cleaning requirements and health risks associated with using the church buildings at this time,
- 2. Unity of the group at this time (the vicarage being a 'group building' and therefore the 'group chapel' belonging to the WHOLE group)
- 3. The sense that we are 'all in the same boat'
- 4. The logistical challenges of opening the buildings under the current regulations

I hope that most of you are able to access the online resources so that we are able to continue to worship together 'virtually'

Rippingale and Dowsby Neighbourhood Plan. Work on the Plan has been suspended subject to the progress combatting the Coronavirus pandemic. The Plan remains under consideration by the Parish Councils; once this is concluded then the next stage is for the completed Plan to be reviewed by South Kesteven District Council. The Government has decided to delay local referendums on the adoption of plan until next year. The Plan, if adopted, will be the local document on which future planning applications will be considered and should guide development proposals. If you wish to contribute to this process in anyway please contact me.

**Playing Field.** Currently, the Government has decreed that play grounds are to remain closed during the current Coronavirus pandemic. Please respect this. The sports court can be used for tennis, to be restricted to two people or a family group, observing social distancing rules. Guidance is affixed to the entrance to the court. The playing field itself is available for individual leisure, again respecting social distancing rules but not for gatherings of any sort.

**Vacancy for a Parish Councillor.** There is currently a vacancy for a Parish Councillor. If you are interested in making a difference in YOUR village, and would like greater information, please contact any Councillor or the Clerk. To be eligible, you must be over 18, on the electoral role and have lived or worked within 3 miles of the parish for at least 12 months.
