Proposed Rippingale Neighbourhood Plan. We have now undertaken the mandatory regulatory 6-week consultation with residents from 1st June to 12th July. The major event to support this was the all-day consultation meeting on Saturday 26th June in the Village Hall 1000 – 1700, with presentations on the proposed Neighbourhood Plan given at 1000, 1300 and 1500. This was relatively well attended.

This Plan will form part of the statutory planning framework for the area, and the policies and proposals contained within the plan will be used in the determination of planning applications. The Plan also affords the opportunity to protect and enhance the facilities and natural features that are most valued in the Village. The Plan, if approved, will be used by SKDC planning officers and elected members of the local authority in assessing planning applications, by applicants as they prepare planning applications for submission to the local authority and by the Parish Council in consideration of planning applications in the neighbourhood.

Thank you to the residents who made comment on the proposed plan; these will be analysed and addressed, and any amendments made to the proposed Plan as necessary.

Next steps. After some further work on a Basic Conditions Statement, a Consultation Statement and Finalising a Sustainability Appraisal, the Plan will then be submitted to SKDC for consideration and a further 6-week consultation with the Village will take place. After this an Independent Examiner will verify the Plan; once this is achieved a referendum on the Plan will be organised by SKDC with the electorate of the Parish of Rippingale to gauge the acceptance of the document.

Tennis Court. The refurbishment of the playing surface of the Tennis Court on the Playing Field is now complete. The Court is open to any residents to play tennis. The entry code can be obtained via 07908 540683.

Vacancies for Parish Councillors. There remain vacancies for two Parish Councillors by co-option. These roles are interesting and satisfying. We are looking for volunteers with a wide variety of skills and backgrounds. If you are interested in contributing to the life of the Village, and would like greater information, please contact me. To be eligible, you must be over 18, on the electoral role and have lived or worked within 3 miles of the Parish for at least 12 months.

Coronavirus Support. With statutory limitations lifted on COVID restrictions, many thanks to the many volunteers and residents who supported the vulnerable and elderly during the difficult periods of the Coronavirus pandemic. This is much appreciated.
