Coronavirus Support. Depending on Government guidance on containing and eradicating the COVID-19 virus, the Village Coronavirus Support Group will continue its operations as long as required. It links with the Lincolnshire County Council and South Kesteven District Council support networks. These local volunteers have been assisting vulnerable and elderly residents, who are self-isolating due to COVID-19. This help includes picking up supplies, posting mail, collecting prescriptions, gardening and assistance with pets. The volunteers are also there for a friendly phone call. Coronavirus lock down measures. As I write we are in Tier 3; the Tennis Court is open again, with up to 6 persons allowed on the court, to play singles and doubles, social distancing rules to be maintained. Additionally, social distancing and cleaning measures should be observed when using the play equipment on the Playing Field. Full instructions are posted. Social gatherings on the playing field are limited to up to six persons (including children of any age) on the playing field. These measures are in place to assist in combatting the spread of coronavirus.

Neighbourhood Plan. Work continues on the Rippingale Neighbourhood Plan, with our consultants actively providing support on preparing the Plan for the pre-submission consultation in the New Year with Village residents. Details will be shared. This will be prior to review by SKDC, before it is sent for independent examination and then a Referendum arranged. This cannot be before May 2021 due to Coronavirus restrictions.

Litter. Litter is the scourge of the countryside and in our villages, towns and cities. Within Rippingale there are many litter bins for use but we still seem to have some people who prefer to litter our streets and grassed areas; I suspect however that the vast majority of litterers are occupants of vehicles passing through the village, who find it easier to dump litter rather than take it home. If you see any litter in the village or adjoining countryside please pick it up and take it home or place it in a litter bin if you can.
